# A Message and Action Steps from Evan Seitz, UU Mass Action Climate Organizer

Hi friends,

I have a confession to make: the election of Donald Trump has thrown me for a loop. I'm feeling sad, numb, angry, fearful. At therapy on the Wednesday after the election I cried for the first half of the session - hardly able to get out any words, and then paused to ask my therapist if he had any suggestions for mourning rituals. After a moment without speaking, he too started crying. I passed him the box of tissues.

We live in sad and scary times. And despite the setback I'm committed to going on; am committed to the slow, careful work of building faith communities of joy and resistance.

Climate justice work will inevitably change with the election of Trump. And not only because Trump is a climate change denier and will almost certainly try to defang the EPA and climate treaties. It will change because Trump has emboldened white supremacy and other hate groups, has threatened religious minorities, immigrants, and the disabled, has trivialized core tenants of our democracy and constitution. With such a broad attack on civil liberties and members of our community, the nature of our movements and our organizing MUST also change.

I don't know what all those changes will look like. I do know that I've felt a need in the short term to mourn. I've cried almost every day since the election. My friends have been similarly affected. My whole social network is grieving, complaining of feeling nauseous, sad, broken. Normally when one of us is down, others are there to pick us up. This time we're down together.

And this has been a time of checking in. I'm sure some of you reading this have received text messages similar to this one. "How are you?" or "Been thinking about you and wondering how you are coping."

I've felt the need to reconnect with loved ones, to re-assert that I'm there for them and they're there for me.

Mourning and reconnecting with loved ones are necessary steps in moving forward. But what comes next?

- 1. We need to prepare to protect those who are vulnerable among us. The Standing on the Side of Love director Caitlin Breedlove created a short <u>video</u> with tips on de-escalation and how to respond if you see someone being harassed.
- 2. We can come together in small groups to process and to begin to plan. The Boston chapter of <u>SURJ</u>, Standing Up for Racial Justice, has created a <u>draft template</u> for hosting a house party to debrief the election with friends or members of your faith community.
- 3. We need to reimagine ways that our congregations can be fortified social movements and serve as sanctuaries in times of increased oppression. <a href="Movement Cosecha">Movement Cosecha</a> is calling on faith communities to declare themselves sanctuaries and provide safe spaces for the undocumented community.
- 4. We need to fortify our grassroots freedom movements, particularly those movements that are led by people of color and Native people (for example <u>Black Lives Matter</u>, <u>Cosecha</u>, and the <u>Water Protectors at Standing Rock</u>). It is social movements not only non-profits that we must support. These movements deserve our money, our presence at actions, and our amplification of their message.
- 5. We need to fortify our ability to resist. We must remember that creating a world of justice has always meant working against long odds. How are we going to support those in our congregation who take real risks in the service of others who are targeted? How do we build power among Unitarian Universalist congregations who have historically, and tragically, too often operated independently rather than built a unified front against hatred, bigotry, and systemic violence?

As Caitlin Breedlove says, we are now in a different political moment that requires new and different skills. Let's be gentle with each other and ourselves as we navigate this new landscape.

# We've collected 161 signatures - let's get it to 500! The deadline to sign has been extended to NOV 23rd.


This is an indigenous-led campaign. UU Mass Action is working in solidarity with the campaign leaders. We ask that you join this effort by taking two actions today:

Over the past year, Maura Healey has:

- Enforced a longstanding provision of state law prohibiting the sale of copycat assault weapons, the weapon used in most mass shootings; and
- Initiated a lawsuit against two gun manufacturers, Remington and Glock, in order to investigate suspected defects in their products leading to injury and death in our state.

As a result of these actions, our Attorney General has been subjected to innumerable personal attacks and lawsuits from the loud and well-funded gun industry and its surrogates.

Thus far, the courts have upheld the Attorney General's efforts. But there is still a long way to go and much work to be done. We need to let Maura Healey know that we applaud her efforts, appreciate her courage, and that she will have our support as she moves forward. # Raise Up Massachusetts Legislative Announcement and Rally

When: Tuesday, November 29th, 2016 at 1:30PM Where: Grand Staircase, 2nd Floor, Massachusetts State House



UU Mass Action and our partners in Raise Up Massachusetts have been on the front lines of tackling income inequality and building an economy that works for everyone. Together, we won an historic increase in the minimum wage, earned sick time benefits for all MA families, and launched a campaign to amend the MA constitution to make millionaires pay their fair share.

The recent election has demonstrated that our work in Massachusetts is more important than ever and we're going to make a legislative announcement regarding a new historic campaign.

That's why we want you to join us on November 29th at 1:30PM at the Grand Staircase on the 2nd Floor of the Massachusetts State House.

On the 29th, activists across the Commonwealth will come together to rally for legislation that Raise Up will be announcing for the next legislative session. <u>Join Raise Up Massachusetts as we hold our legislators accountable to all workers in the Commonwealth.</u>

### Rally & Press Conference - Jobs Not Jails


When: Tue Dec 13th at 10:00 AM

Where: 140 Bowdoin St, Church of the New Jerusalem (across from the

State House, on the side)

The Governor, Speaker, Senate President, and Chief Justice will JOINTLY file a bill in mid-January on criminal justice reform. It will include some of the recommendations of a report the Council of State Governments (CSG)

will publish on the criminal justice system in Massachusetts that will be released when their bill is filed.



b. BUT THE CHALLENGE: The bill they file will very likely NOT be comprehensive enough and will likely focus on the "back end" of the system on probation, parole, and some aspects of recidivism but NOT on the "front end" of the system like repealing long mandatory minimum sentences on non-violent drug offenders etc. Read more about the Jobs Not Jails Priorities

To meet this challenge of getting a stronger bill passed than the one the 4 State leaders will likely file, we are taking these actions that you can help with....

- 1. Attend the Rally / Press Conference on <u>December 13 at 10:00</u>. Jobs NOT Jails will have a rally/press conference to call on the 4 state leaders to include the 6 proposals of the Jobs NOT Jails Coalition
- 2. **Contact your legislators** and/or come to the Jobs Not Jails Lobby Day in January ask that they cosponsor the omnibus criminal justice reform bill, **The Justice Reinvestment Act**, which will include the Jobs Not Jails Priorities. (more details to come on this filing deadline is Jan 20<sup>th</sup>)
- 3. In March 2017, the coalition will be organizing 6 or more **major public action** meetings in Boston, Brockton, New Bedford, Worcester, Springfield, Lynn, Lowell to show large scale public support from major criminal justice reform and engage legislators, mayor, sheriffs, police chiefs in standing with us in support. Let us know if you can help organize one of these events or offer a meeting space

Find out what reform bills may be introduced in the 2017 state legislative session based on recommendations of the Council on State Government [CSG], under the PEW Research Center. The CSG/PEW are neutral organizations that support justice and good state governments. Massachusetts leaders invited the CSG to study current justice practices and systems in the Commonwealth and offer bi-partisan recommendations for bills to be introduced in the next session.

Laura Wagner, director of Unitarian Universalist Mass Action Network, will be the lead speaker. UU Mass Action is a member of the partner organizations working group that have been meetings with the CSG over the past year.

The Mass. Statehouse operates on an 18-month calendar, starting in January 2017. During the first three weeks of January, legislators must introduce bills to be considered for the new session, with cosponsors. The Governor appointed a 25 member panel of state employees and legislators to partner with the CSG in this project. They have been meeting regularly for the past year.
