### 1) Stories, Stories, Stories...

Our elected officials have told us on numerous occasions that what they remember most are personal stories. The Raise Up Mass Coalition is gathering stories which demonstrate the impact the \$15 Minimum wage bill will have on thousands of workers in Massachusetts. We are also looking for stories from families who have added a child to their family or have had to deal with significant illness.



- 87% of workers in New England lack Access to paid leave
- 1.2 million workers risk losing their jobs if they take time off to care for a family emergency or to care for a new child.
- Many workers who are eligible for leave under the federal Family & Medical Leave Act can't afford to take unpaid leave and have to choose between keeping their job and caring for a loved one.

The MA Paid Family & Medical Leave bill would be paid through employer premium contributions to the new Family & Medical Leave Security Trust Fund or to a private insurance plan. Four states now have Paid Family & Medical Leave. In a survey six years after California's law was passed, 89-99% of employers reported either a "positive effect" or "no noticeable effect" on productivity.

**Hardworking people in Massachusetts shouldn't have to choose between working at their job they need to pay the bills and caring for themselves or the family they love in a time of crisis.**

## 3) Sign on Letter for Ending Mass Incarceration

Led by the Coalition for Effective Public Safety (CEPS), a sign-on letter has been created demanding that state leaders make good on promises to improve fairness and outcomes for those in the system, reduce prison and jail populations, decrease recidivism, and cut prison costs. We also urge the Governor and legislators to take responsibility now in executive actions and legislation to address long-standing failings of the Department of Correction and the Parole Board.

## 4) Build a Relationship with your Local Mosque

It's striking that when asked, many people respond that they don't know a Muslim person. It's easy to generalize and fall victim to fear based responses when discussing a group of people who are unknown to you. The best way to turn away from fear is to embrace compassion, love and learn to really see our neighbors fully. It's so exciting to hear about UU congregations who are building relationships with their Muslim neighbors!

Here are a few stories about what's been happening - please share your story as well!

**UU Church of Medford - submitted by Michael Glenn**

On Sunday February 5<sup>th</sup> UUCM hosted a group of local Muslims both at our service and at social hour afterwards. They people came from the Malden Islamic Center and from a congregation of Bangladeshi Muslims who live in Medford.

The service that day was a social justice service on “Radical Welcome,” led by Heather Vickery, chair of the social justice committee at our sister UU church in Malden. Heather recently returned from a trip to the US-Mexican border, and she works at the UU College of Social Justice in Cambridge. In fact, it was through Heather that we first met the folks from the Malden Islamic Center—they cooked an iftar dinner at the Malden FPC last June, and Heather invited a group from our social justice committee to attend. It was a lovely event.

We returned the favor by preparing a nice lunch for our visitors on February 5. Social hour began with a few speeches of welcome, and then we served a buffet-style lunch. We set up small tables, so people could share the meal with our visitors... and we could each get to know one another better.

All of us need friends, and at a time like this it’s important that none of our neighbors is singled out or scapegoated. Through this event we want to assure our Muslim neighbors that we’re glad to be part of the same community. Getting to know one another is part of what we’re all about.

This event was enthusiastically approved by our Board. It represents yet another way (like the Medford MLK Day brunch and the Medford Conversations) that we’re trying to reach out beyond our walls and encounter our neighbors.

One immediate result of our contact with the Islamic Center is, that they’ve invited our middle school RE class and their teachers to visit the Center some Sunday in February following this event, so that the class can learn more about Islam.

This event was a huge success. About 100 people came, including 20 or so Muslims. The sermon and service were spot-on. The choir sang a welcoming song in Arabic. Speeches of welcome were given and responded to. And everyone enjoyed lunch at the small tables... conversation went on from noon to close to 2:00. Just to let you know, good things are continuing to happen all over the place...

## 5) What's happening with the Sanctuary to Solidarity Movement?

Our numbers are growing! UU Mass Action is a member of the interfaith team working to take action - the leaders of this team are now meeting weekly to coordinate our efforts. The team includes, MCAN (MA Community Action Network), Episcopal City Mission, Roxbury-Dorchester Power in Community, the Jewish Community Relations Council and many others.

Once you have this app installed, you can communicate via encrypted texts and phone calls with others who also have signal. Lead organizers will be able to set-up groups and communicate quickly - and securely - with those who within the rapid response network.

## 6) Pilgrim is shut down - Call to Action

The decision by Entergy to shut down the troubled Pilgrim reactor before the recent blizzard is a serious acknowledgement that Pilgrim is in very bad shape. Just like the public, Entergy has no confidence Pilgrim can operate safely. The NRC and Entergy will most likely spin this decision as a responsible action in light of the storm. But what this actually indicates is a real serious risk to public health and safety. It doesn't take just a blizzard for an emergency scram. The documented poor safety culture, ongoing equipment failures, and lack of maintenance all add up to danger any time, every day. Where is the Governor's voice for public safety? Keep Pilgrim shut for good.

Call Governor Baker and AG Healey to demand the NRC keep Pilgrim closed.

**Peace and Prayer for Humanity: Report From Standing Rock/DAPL Pipeline**

Members of the Standing Rock Sioux Tribe, other Native American Tribes, and non-Native allies gathered in the thousands in North Dakota to prevent the building of an oil pipeline under the Missouri River by the Dakota Access Pipeline (DAPL) Company, threatening the water source for 18 million people. The "Water-Protectors" succeeded in halting the construction a few weeks ago, pending environmental assessments. But now Donald Trump has directed the Army Corps of Engineers to immediately approve the final step of the pipeline.

In the freezing cold, Native people are putting their bodies on the line and resisting this injustice by Trump. Thousands are joining them again, including our own community members. Together, they will be facing highly militarized forces. We must show equal fortitude!

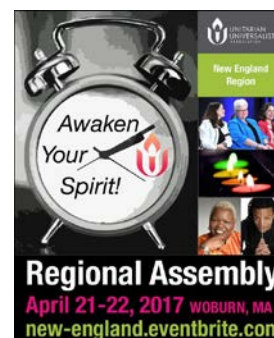

## RESOURCES

Consumers for Sensible Energy, MassPLAN, Mass Energy Consumers Alliance released a report this week on Access NE. Here is the [Report](#) from Synapse.

Highlights: pipeline will cost ~\$6.6 billion (that's twice what it is being estimated as the cost);

- Even if pipeline does what proponents say it will regarding winter demand, it will cost NE consumers more overall, not less
- Given all laws and regulations around increases in renewable energy and decreases in greenhouse gas emissions, use of gas for electric generation will decrease by 23% in next 15 years, and will drop dramatically in 1.5 years after ANE would come online.
- With electricity demand flat, new energy like wind and hydro would displace existing fossil fuels. By 2030, 41% decrease use of natural gas for electric generation.

Through a joint UUSC, UUA, and College of Social Justice's Solidarity and Sanctuary initiative, the **Congregational Action Guide** has been published which offers a wide range of suggested actions related to making municipalities, counties, and schools safer, more welcoming for all – particularly undocumented immigrants, Muslims, people of color, and the LGBTQ community. The actions vary in the amount of energy and experience required so as to provide ideas for congregations of different sizes, capacities, and political environments. Some are geared towards policy advocacy while others involve developing and strengthening relationships with grassroots groups doing local organizing.
